Founded in 1997, SNYP has annually grown in both scope of programs offered, and number of clients served. Today, SNYP receives over 3,600 calls a year. Every caller is helped either through our referral service or through one of our many assistance programs.

All Rogue Valley animal welfare organizations refer their callers to SNYP for spay/neuter services. In addition, we assist many of the animal rescue groups which provide their invaluable services to hundreds of animals who never enter the shelter system.

SNYP's outreach programs include partnerships with many of the human assistance organizations in southern Oregon, thus helping our community's low income population while saving animals lives at the same time.

SNYP's work goes beyond the borders of the Rogue Valley. Through our educational materials and spay/neuter booklets we have helped organizations as far away as Canada, and as close as Yreka and Klamath Falls to begin their own spay/neuter programs.

How you can support SNYP's work now and in the future.

A bequest in your Will or Living Trust is a way to help SNYP continue our ongoing life-saving work. We hope you will consider us for a lifetime gift or bequest when planning your estate.

There are many options for planned giving which can provide you with tax benefits while helping the animals. Some types of planned gifts virtually eliminate estate taxes, while others greatly reduce the amount of tax you are responsible for. It is important to explore your options so that both you and the animals receive the full benefit of any considered gift.

A bequest may take several forms. It can be a specific sum, a percentage of your estate, or the remainder of your estate after expenses. Bequests can include cash, securities, real estate, or personal possessions such as valuable collections, art, or jewelry.



What if I already have a Will?

If you already have a Will and would like to include SNYP in your estate plans, your attorney can prepare a Codicil for you. A Codicil is a short legal document that amends your present Will.

To substantially reduce federal and state estate taxes and to ensure that your property will be distributed as you desire, your Will should be prepared by an attorney experienced in estate matters.

What is SNYP's financial responsibility?

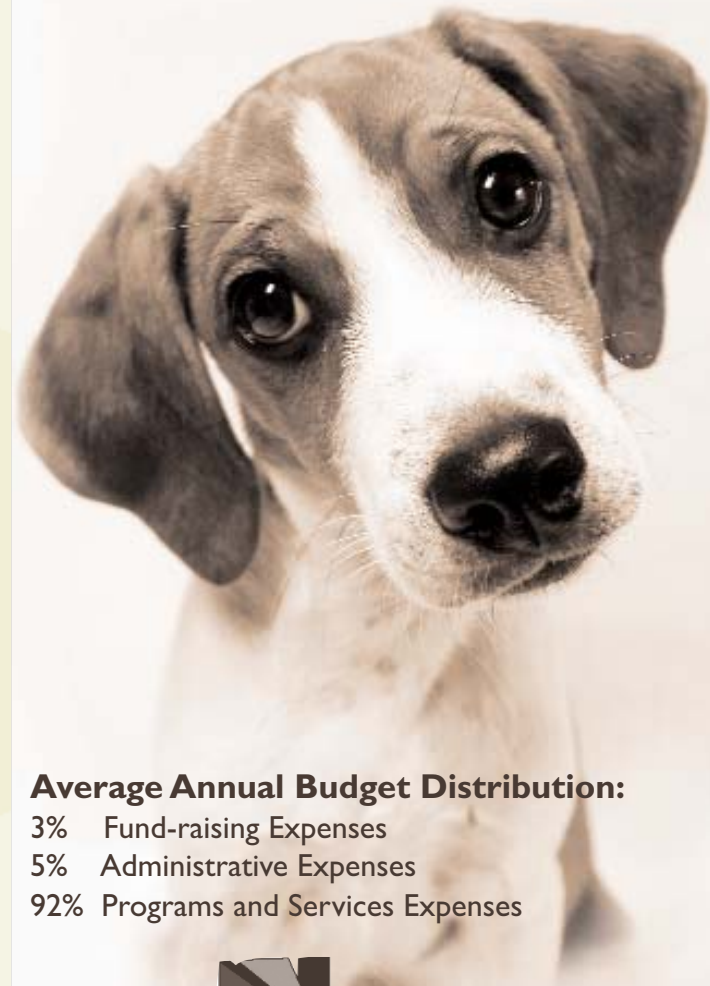
SNYP is an all volunteer organization made up of dedicated individuals working from their homes. Overhead expenses are kept to a minimum so that funds are used primarily to provide service to animals. Ninety-two percent of our funds go directly to spay/neuter programs.
